TREEDC Leaders Visit Congressional Members

TREEDC leaders from Memphis, Jackson, Ducktown, Knoxville, and Tennessee Tech University met with the U.S. Tennessee congressional delegation on February 2 and 3. The objectives of the trip were to provide an informational update about the 2011 activities of the Council and to express appreciation for the Tennessee Valley Authority's (TVA) support of TREEDC.

Memphis City Councilman Edmund Ford, Jr. met with Congressman Steve Cohen to share the TREEDC work of assisting the Tennessee Valley Authority (TVA) with the Green Power Switch Pilot Program. Jackson Councilman and TREEDC Legal Affairs Director Ernest Brooks, II discussed clean energy initiatives in his community with Congressman Stephen Fincher and an update on the success of the recently installed 1 MW Solar System at the Jackson American Business Center.

Dennis Tennant, Tennessee Tech University associate director of external relations, shared the success of the Tennessee Tech REDI Economic Development Program with Congressman Diane Black's office.

Additionally, Ducktown Mayor and TREEDC President James Talley discussed Ducktown's solar initiatives with Congressman Chuck Fleischmann. Mayor Talley recommended new statewide incentives for solar energy development, cellulosic ethanol production, biomass gasification and waste to energy.

TREEDC Visits Hiwassee

The TREEDC Forum was held at Hiwassee College on February 24 and contained speakers who discussed information pertaining to TVA's Green Power Switch, UT's Solar Decathlon, Cleveland State Community College's Green Incubator and much more. 74 people were in attendance at the forum in which TREEDC Consultant Bill Owen urged participants to sign up for the TVA Green Power Switch program for only 14 cents per day. Harvey Abouelata, president of ARiES Energy discussed a process to convert cellulosic biomass to hydrogen power for energy. This system, which uses a thermal gasification process, can provide power to 55 homes while consuming 1.6 tons of biomass and municipal wastes per day. Genera Energy President Dr. Kelly Tiller gave an update on the progress of the statewide Cellulosic Biofules Initiative, which has the goal of developing 10 commercial biorefineries across the state, which would create 6,000 direct jobs. There was also a student break out session in which students discussed ways to stay green on campus. Check out their ideas on the next page.

Students Brainstorm at Hiwassee

During the student brainstorming session at the Hiwassee TREEDC forum, UT and Hiwassee students discussed some of the great things Hiwassee College is working on to become more sustainable and energy efficient. Initiatives are already in place at Hiwassee, and students spoke about some of the things UT does through their Make Orange Green initiative. These are things Hiwassee could implement as well. Here is a recap of what was discussed...

- **Turn off the lights when not in use**. Here at UT, we have stickers on every light switch in the dorms, reminding students to turn off the light when they leave a room. This is a simple and quick thing to do, and it can have a big impact.
- Recycling bins all throughout campus and in each dorm room. UT hosts a friendly competition between dorms to see who can recycle the most materials over a month. This would be a neat idea to do at Hiwassee, and each dorm floor could compete to see who could save up the most over a month.
- Trade in old light bulbs for newer, more efficient ones at the light bulb exchange. This is hosted in the lobby of the dorms twice a year, and students can trade their old bulbs for new, efficient ones.
- Come up with a unique idea! Hiwassee could host a competition to see which student could come up with the best idea on ways to be energy efficient, ways to get students involved, and how to get the word out about being energy efficient.
- Gain involvement, awareness, and brainstorming groups. Get a club or group together to meet frequently, even if it's just to discuss ideas over lunch. Being a part of an energy efficiency group would look great on a resume, and you could potentially make a big impact on campus! Get the word out by the school newspaper and the newspaper's Facebook or Twitter site.

TREEDC Welcomes New Members

During his presentation at the March forum, Vis-Solis Managing Partner Tim Hayes praised TREEDC member Lincoln County and Brown Construction for bringing clean energy to the grid and returning economic vitality to Lincoln County in 2011. 60 people were employed during project construction.

Also during the past quarter, the Tennessee Gas Association (TGA) joined the TREEDC family as a Gold 2012 Founding Member. TGA and TREEDC have been actively promoting and working to incentivize compressed natural stations for private and public fleets across the state. TREEDC Member ECOtality Partners with Chevrolet Volt



TREEDC Tennessee Department of Economic and Community Development announced earlier this year that Chevrolet Volt purchasers are now eligible for the state's \$2,500 electric vehicle (EV) rebate. The rebate requires that consumers qualify for and participate in The EV Project, a national study on EV use and charging infrastructure deployment.

The EV Project will provide participants with a free Blink® 240V networked charge station and a credit of up to \$1,200 toward its installation. To be eligible, Tennessee residents must sign an EV Project participant agreement, purchase the Volt, take delivery of the car, and have SPX Corporation install their Blink charge station by June 30, 2012. Volt owners who have already purchased and taken delivery of their vehicles are still eligible for the rebate if they are accepted into The EV Project. Consumers should contact the original selling dealer to inquire about retroactive rebates.

The primary goal of The EV Project is to collect, analyze and report on the use of electric vehicles and the infrastructure needed to support them. This information includes data regarding the energy used, along with time and duration of charger use. No personal information is shared or included in the analyzed data. Participants must maintain an in-home Internet connection to transmit the data until The EV Project concludes on April 30, 2013.

In September of 2010, the state of Tennessee announced that \$2.5 million had been budgeted for the electric vehicle rebate program, enabling the first 1,000 Tennessee residents who purchase either a Chevrolet Volt or Nissan LEAF SL, the opportunity to participate in The EV Project and receive a \$2,500 rebate. The state rebate is in addition to a federal tax rebate of up to \$7,500.

ECOtality is the project manager of The EV Project and will oversee the installation of commercial and residential charging stations in 18 major cities and metropolitan areas in six states and the District of Columbia. The project will provide an EV infrastructure to support the deployment of EVs in these key markets. The project is a public-private partnership, funded in part by the U.S. Department of Energy through a federal stimulus grant and made possible by the American Recovery and Reinvestment Act (ARRA).

President Talley Participates in the Capitol Bioenergy Day in Washington, D.C.

On March 21, 2012, TREEDC President James Talley joined representatives from more than 20 bioenergy stakeholder groups in Washington DC by participating in the 2012 Bioenergy Partners Capitol Hill Day. Leaders from the biofuels, biopower and bioproducts industries, as well as agriculture and other related industry interests, are encouraging lawmakers and key decision makers to adopt a diversified national energy strategy that includes bio-based renewables as a critical component.

An "all-of-the-above" approach to energy policies and investments was the primary topic of a Congressional staff briefing and panel program in the morning. Afternoon efforts included small groups making office visits with Congressional leaders and their staff, sharing with them the wide range of issues facing bioenergy, while detailing the opportunities that bio-based energy solutions provide.

Economic and Community Development Energy Director Molly Cripps Gives EECDBG in Columbia



Tennessee Economic and Community Development (ECD) Energy Director Molly Cripps gave a thorough update of the 3 funding rounds of the Stimulus funded Energy Efficiency Community Development Block Grants (EECDBG) which have provided needed funding to 145 local government projects across the state. Cripps stated that TREEDC members East Ridge and Sunbright were successful in completing their programs which resulted in significant annual energy savings to these communities. Cripps also reviewed other successful projects that involved building retrofits, LED traffic lights and more efficient street lighting for local governments.
